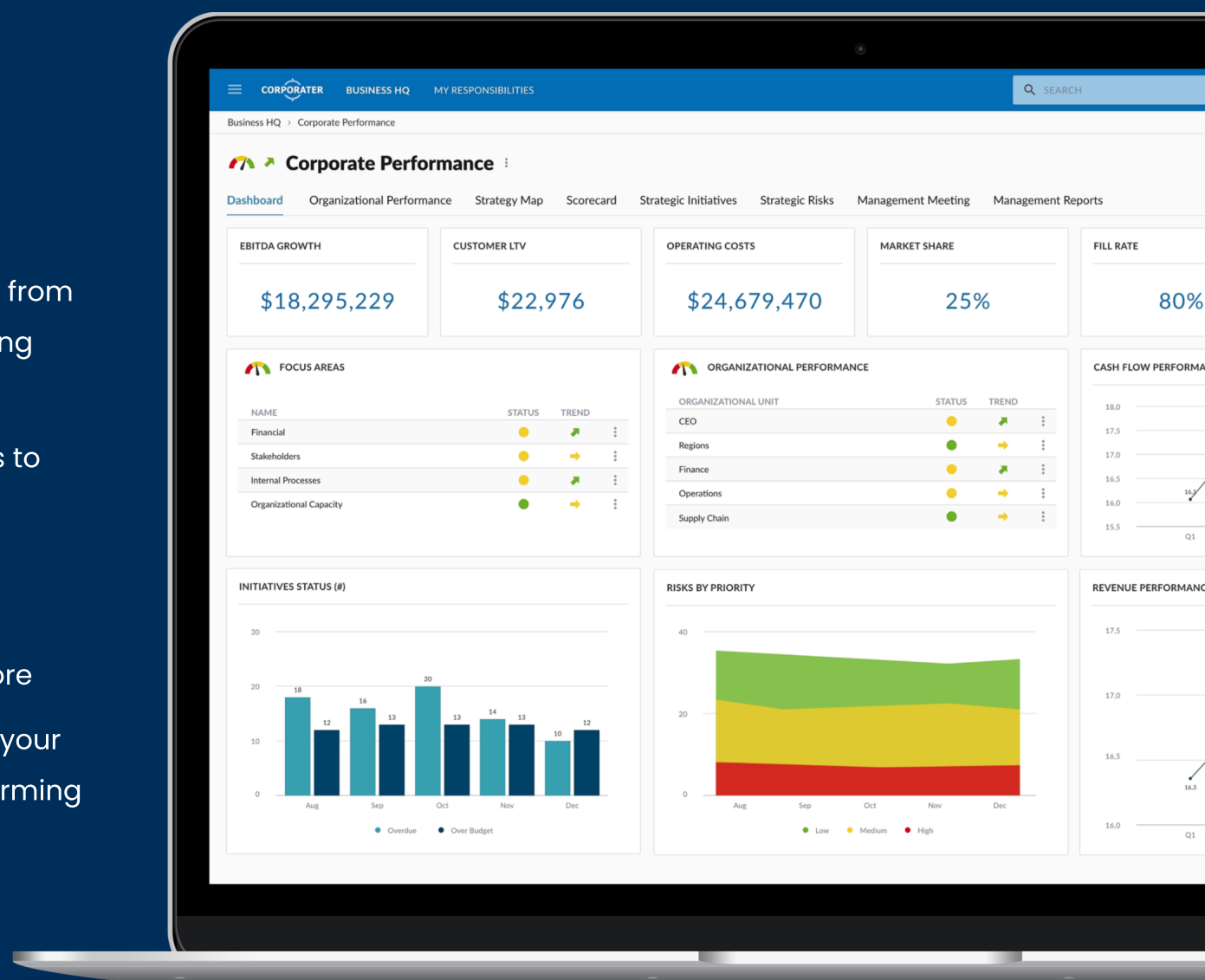

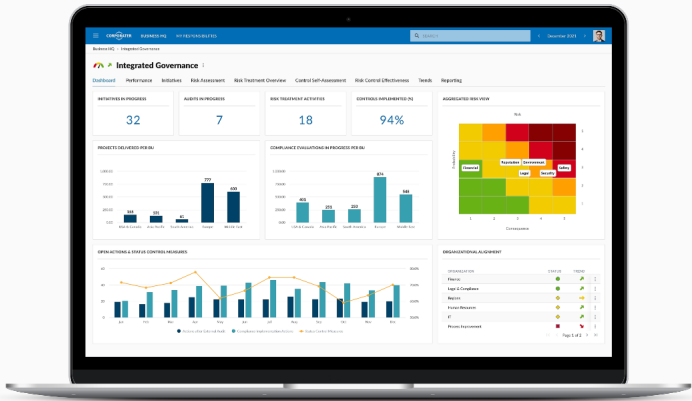


Corporater Corporate Dashboards

Policy Management Dashboards

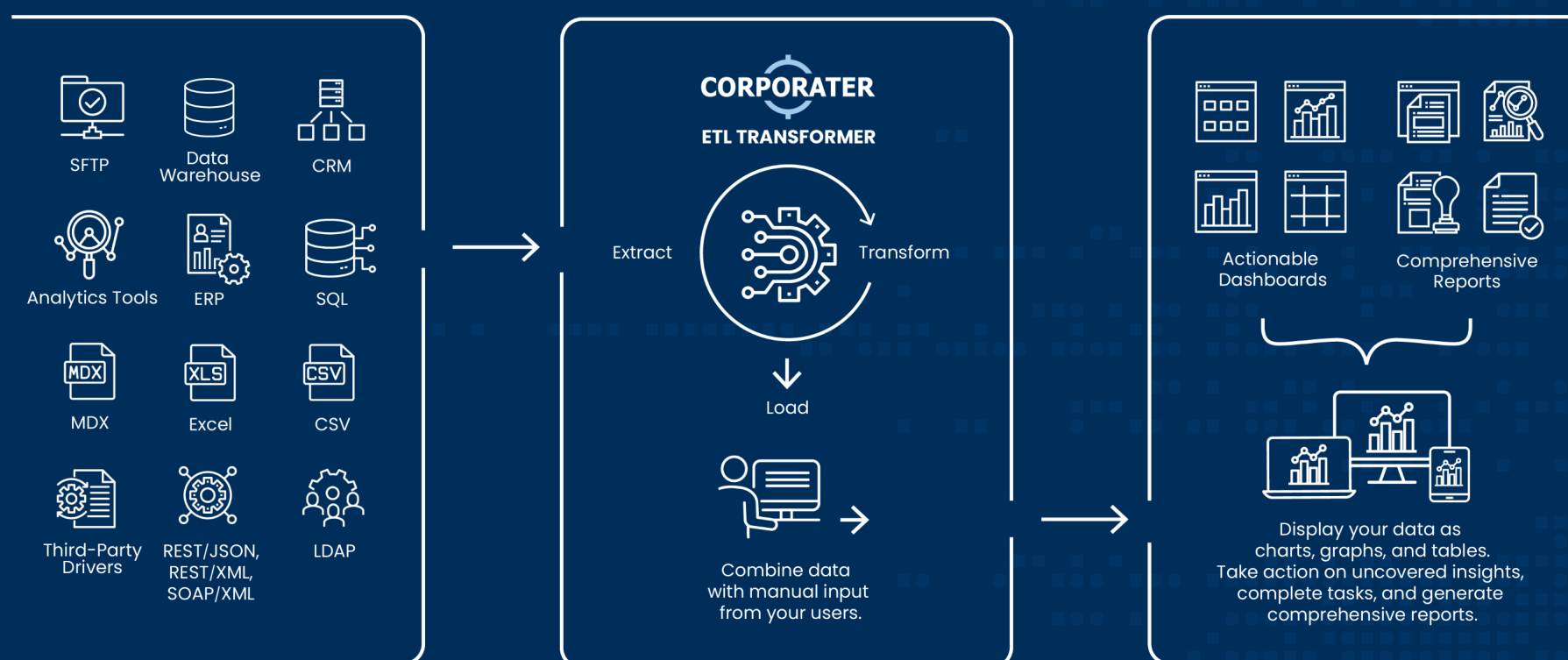



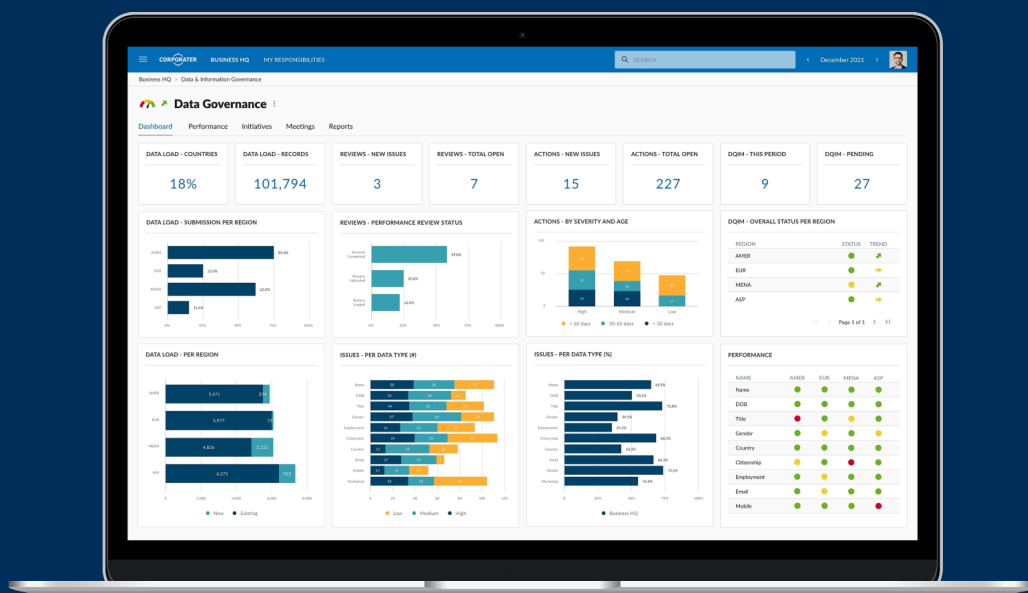
