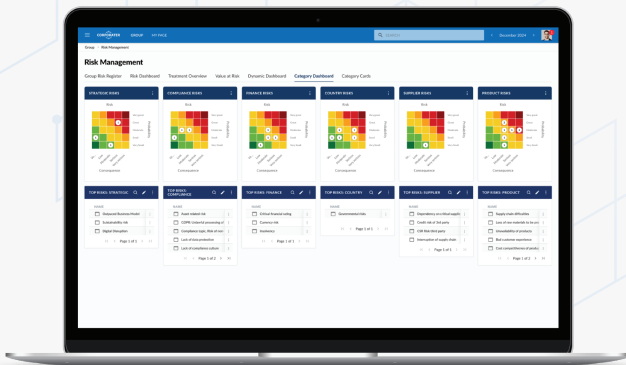


Centralized Risk Management

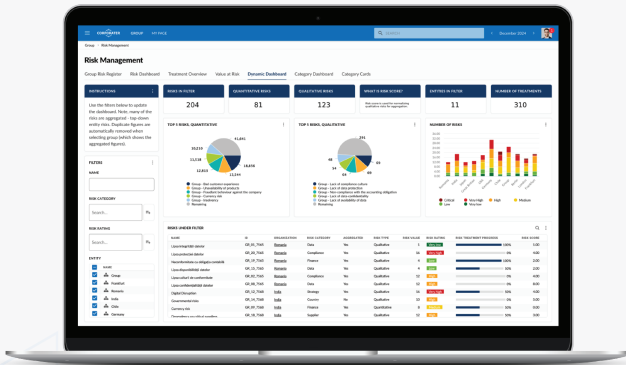
Dynamic Risk Monitoring and Assessment

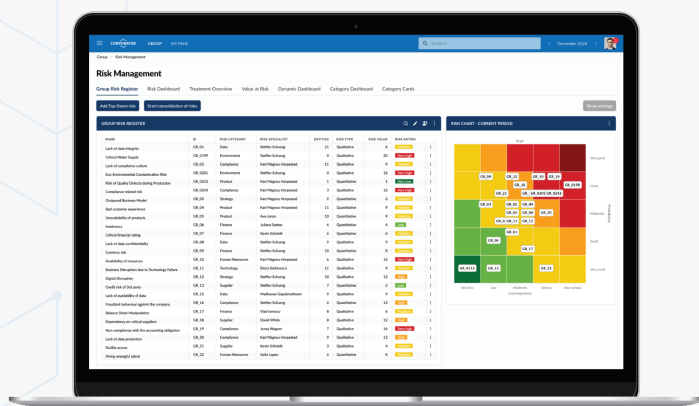
