
MAS IAC Compliance Management



Manage all 5 MAS outcomes

- Outcome 1: Senior managers who have responsibility for the management and conduct of functions that are core to the FI's operations are clearly identified.
- Outcome 2: Senior managers are fit and proper for their roles and held responsible for the actions of their staff and the conduct of the business under their purview.
- Outcome 3: The FI's governance framework supports senior managers' performance of their roles and responsibilities, with a clear and transparent management structure and reporting relationships.
- Outcome 4: Material risk personnel (MRPs) are fit and proper for their roles, and subject to effective risk governance, and appropriate incentive structures and standards of conduct.
- Outcome 5: The FI has a framework that promotes and sustains the desired conduct among all employees. FIs are free to decide how best to meet these outcomes in a way that is relevant to the nature, size, and complexity of their operations.




Identify emerging risks and opportunities

STEP 2



Adopt


Adopt appropriate measures for your FI. Adapt specific guidance as necessary, based on nature, size, and complexity of your business.

Regularly review effectiveness and adequacy of measures. Take into account gaps between observed behaviors and desired standards of conduct.




