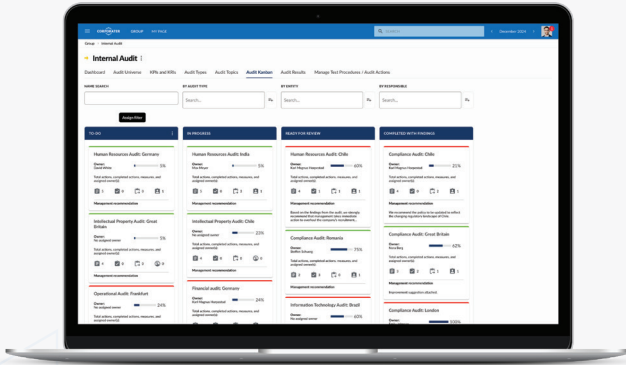
KPIs and KRIs

- Set up automated alerts to notify teams when KPIs or KRIs move outside acceptable thresholds, ensuring proactive risk management



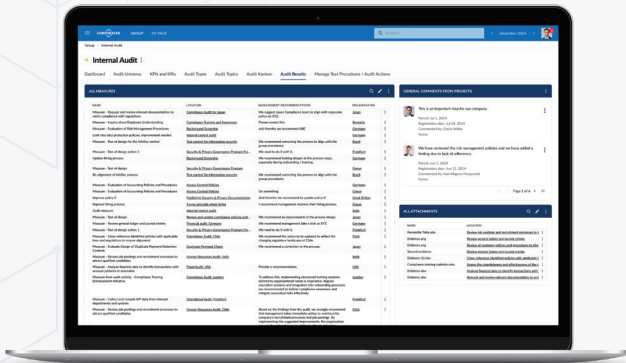

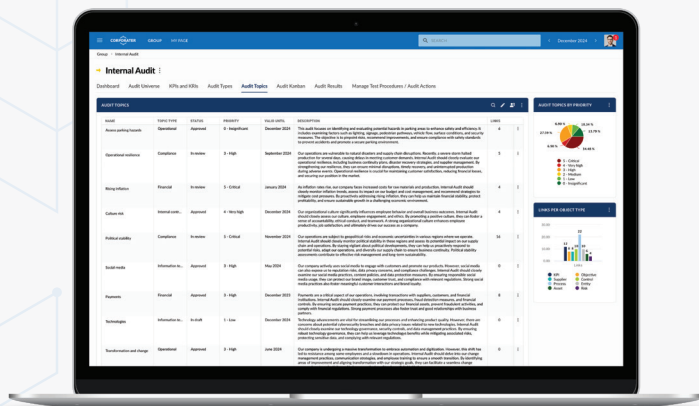
