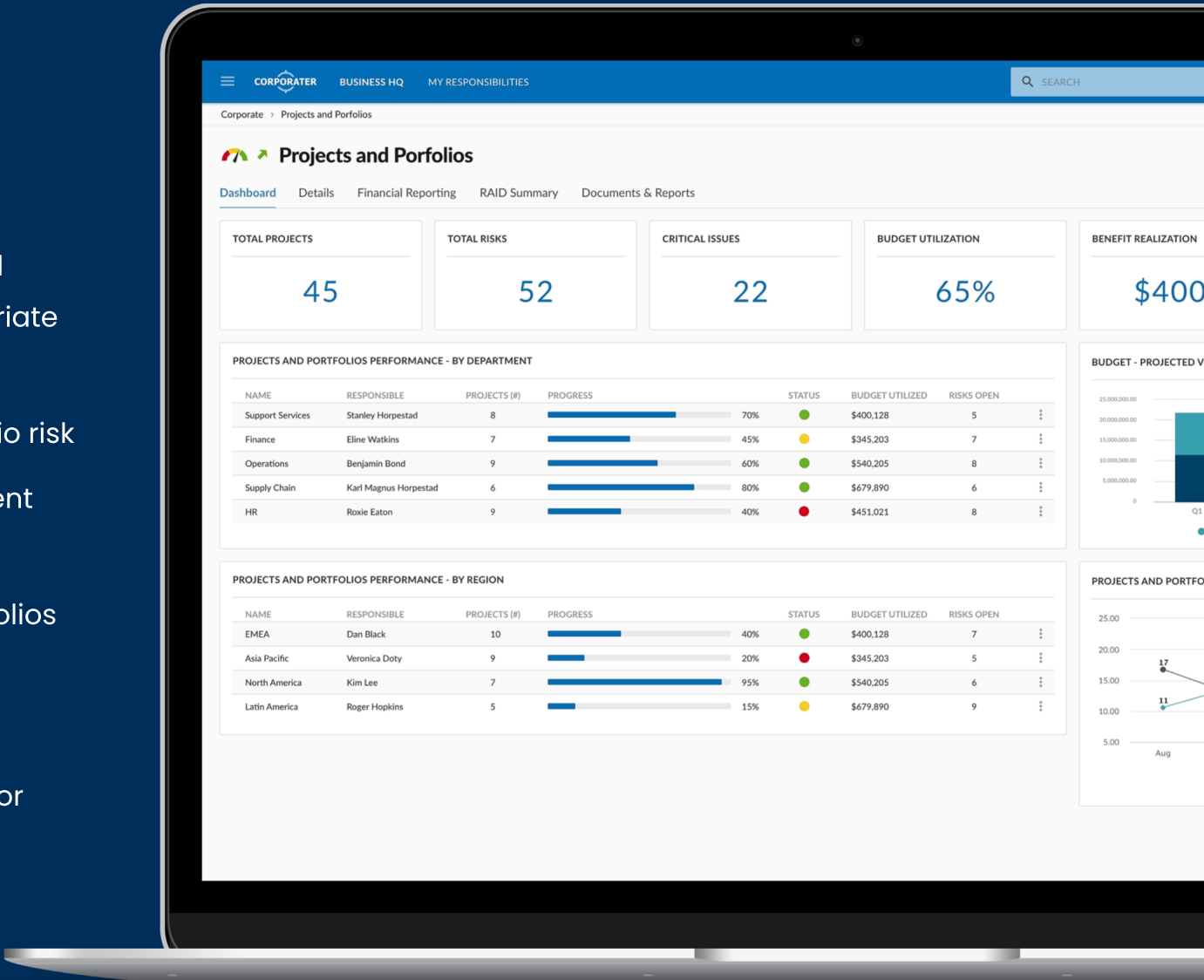

Create custom actionable project and portfolio risk dashboards for your teams, business units, or senior leadership.

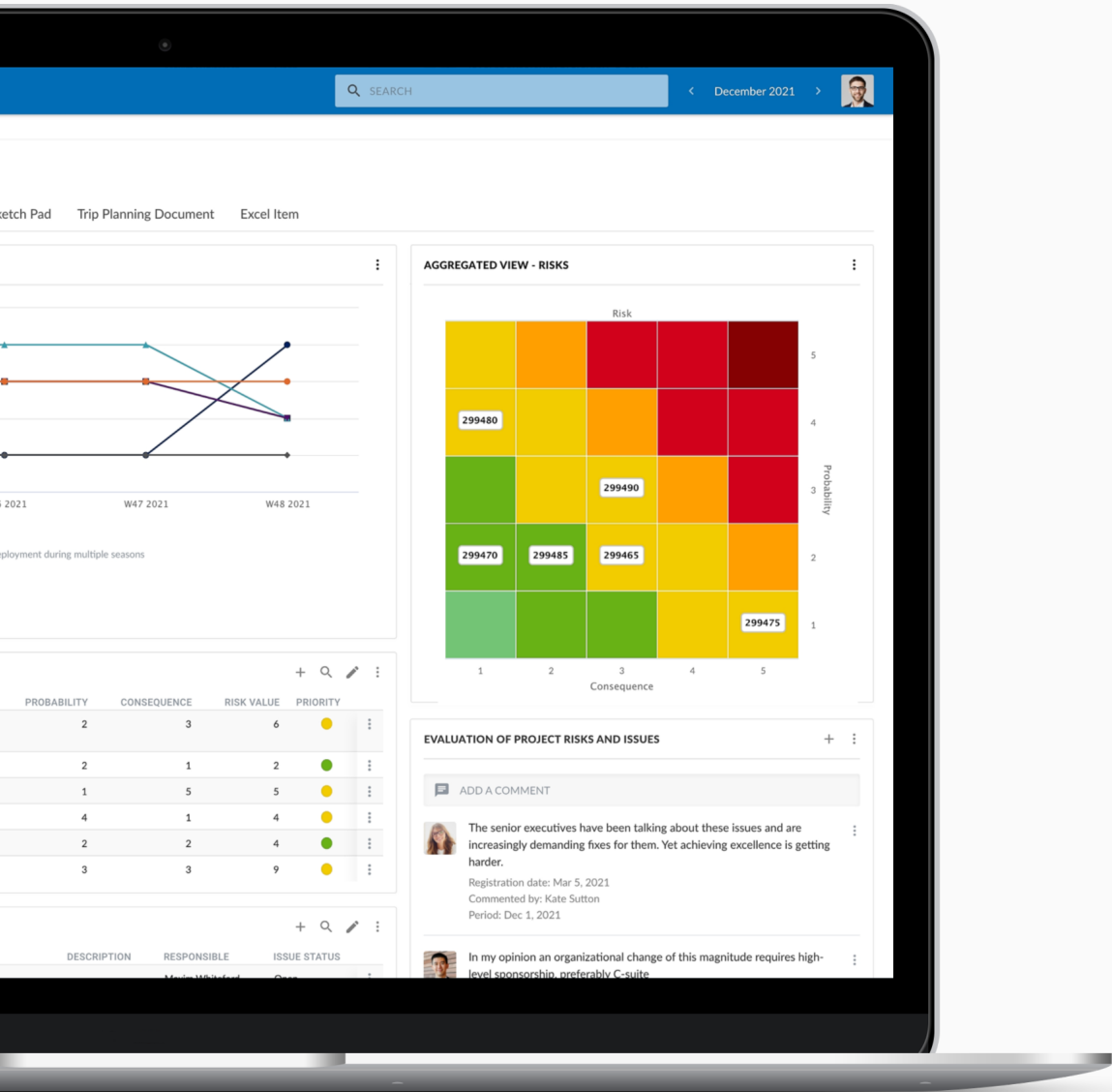

Take action on identified risks

Identify and analyze risks within your portfolio and address identified risks with an appropriate response to increase the probability and impacts of positive risks, and decrease the probability and impacts of negative risks.

- Define custom risk treatment actions specific to your organization, assign risk owners, and document all decisions in a clear manner
- Create task lists and track task completion
- Set up automatic notifications to communicate assignments, responsibilities, approval status, and overdue tasks

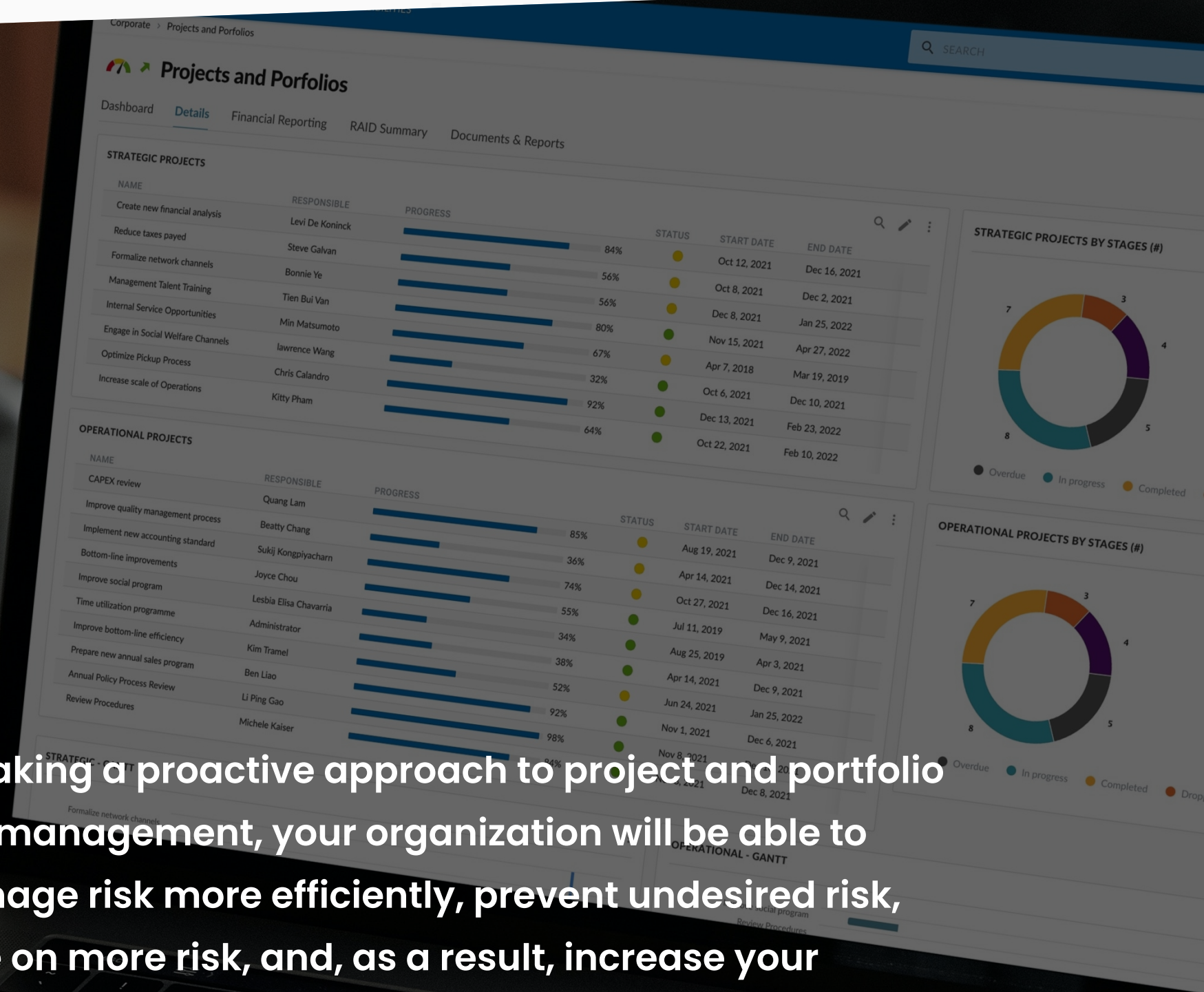




Generate project and portfolio risk reports

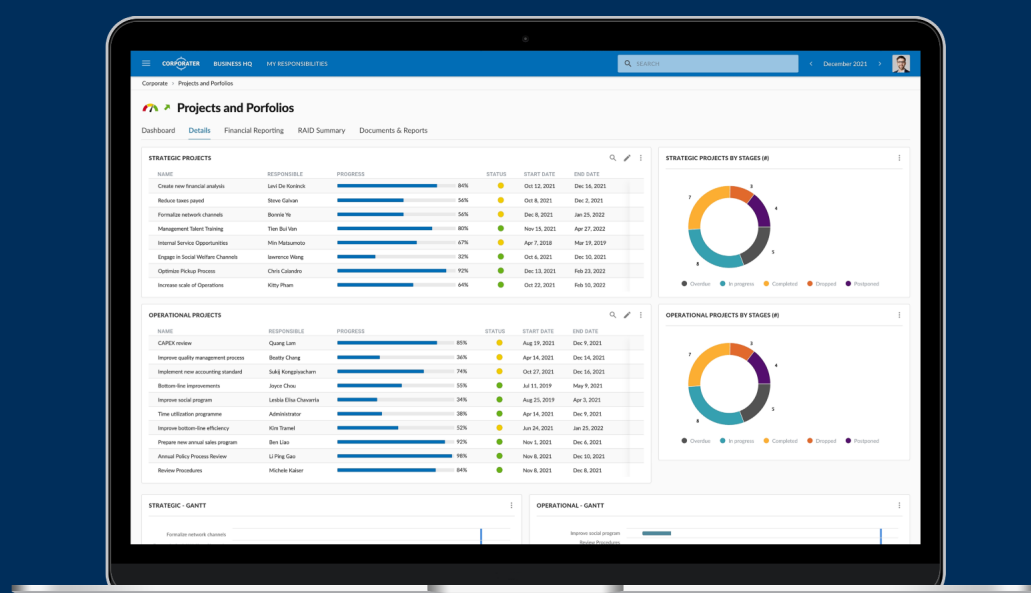

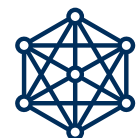
