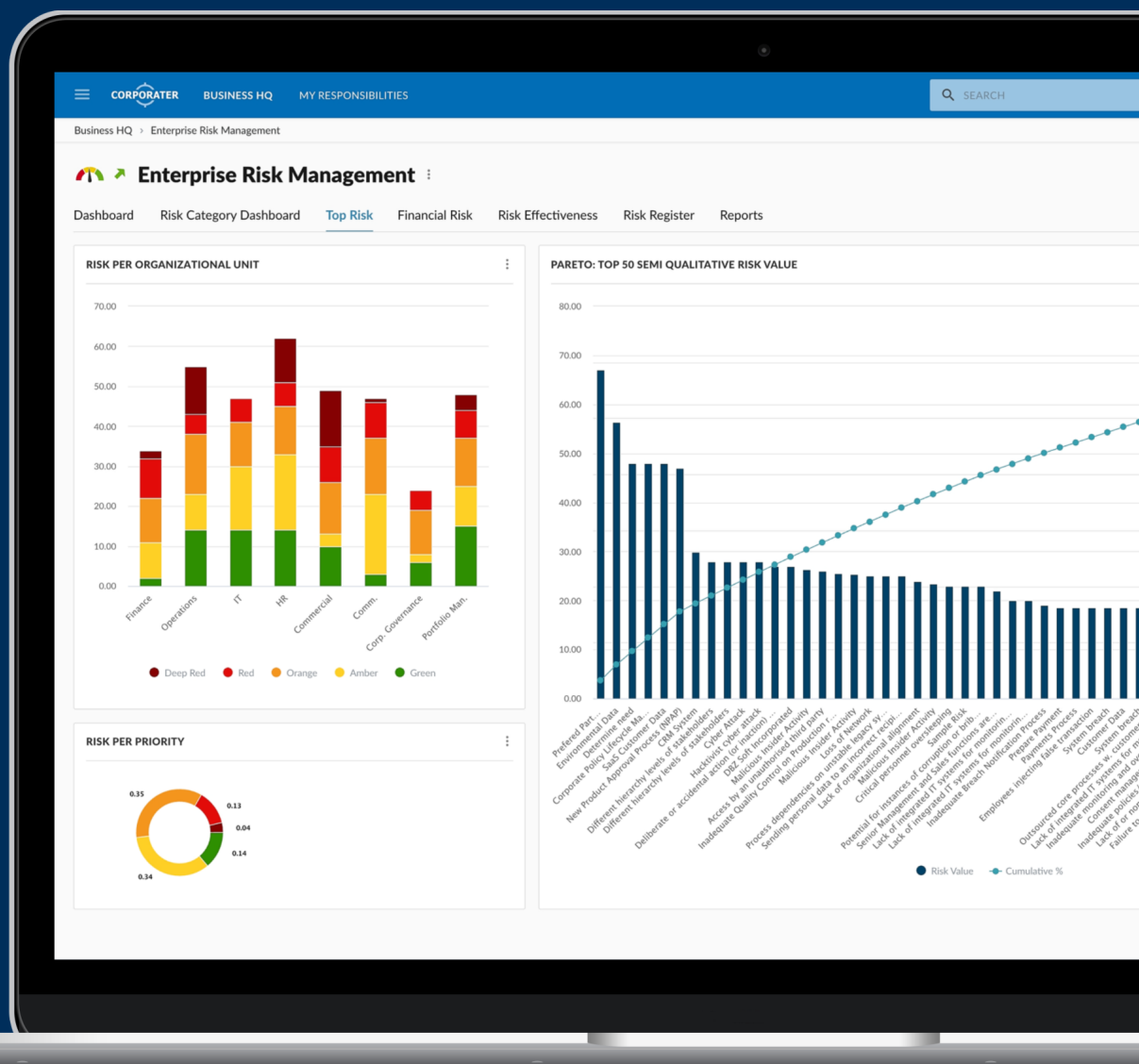
Enterprise Risk Management

Define risk areas that could pose a threat to the company's existence across all departments, levels, and processes, and communicate them across your organization.

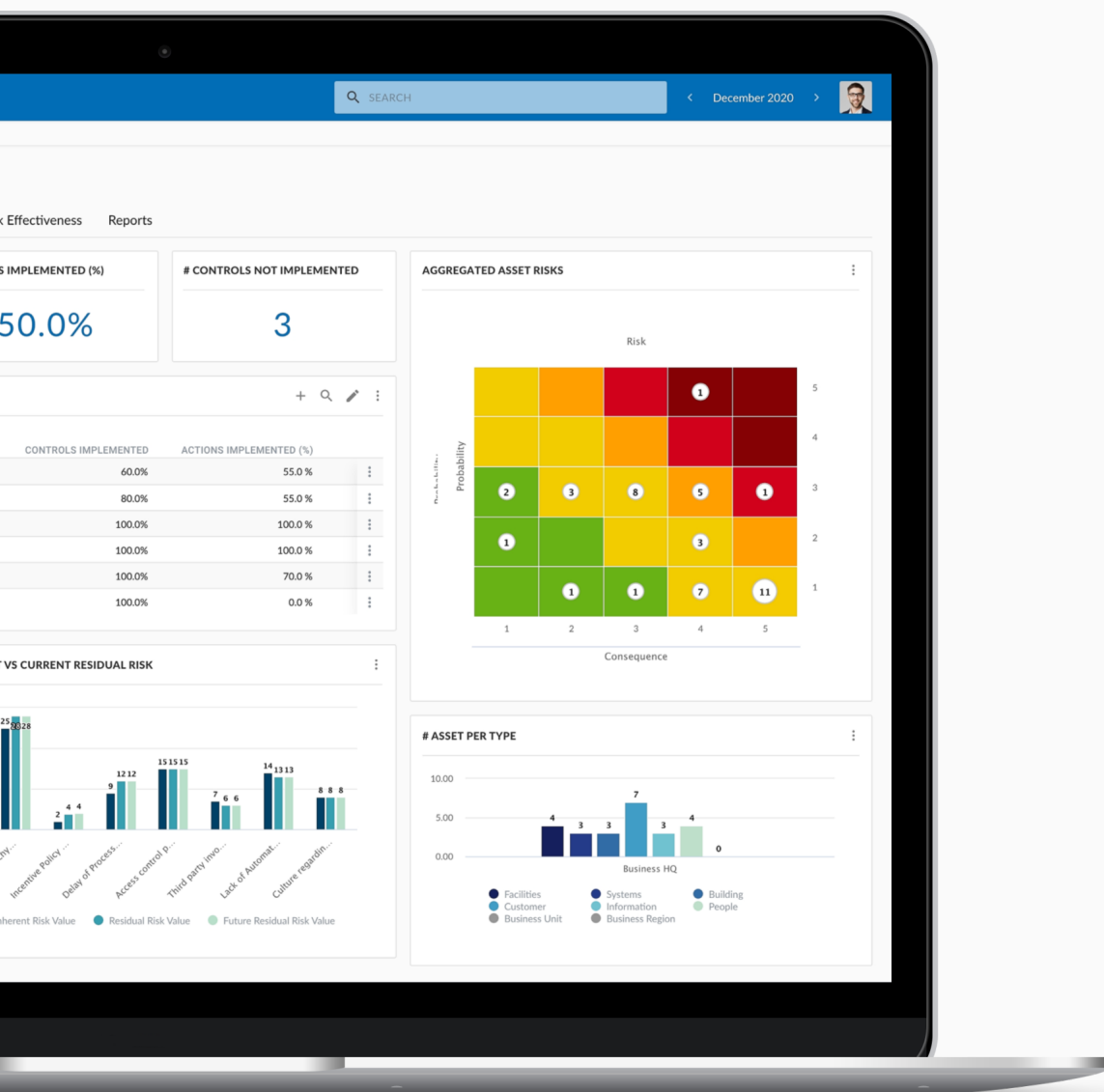
- Proactively monitor, identify, assess, address, and report vulnerabilities across your organization

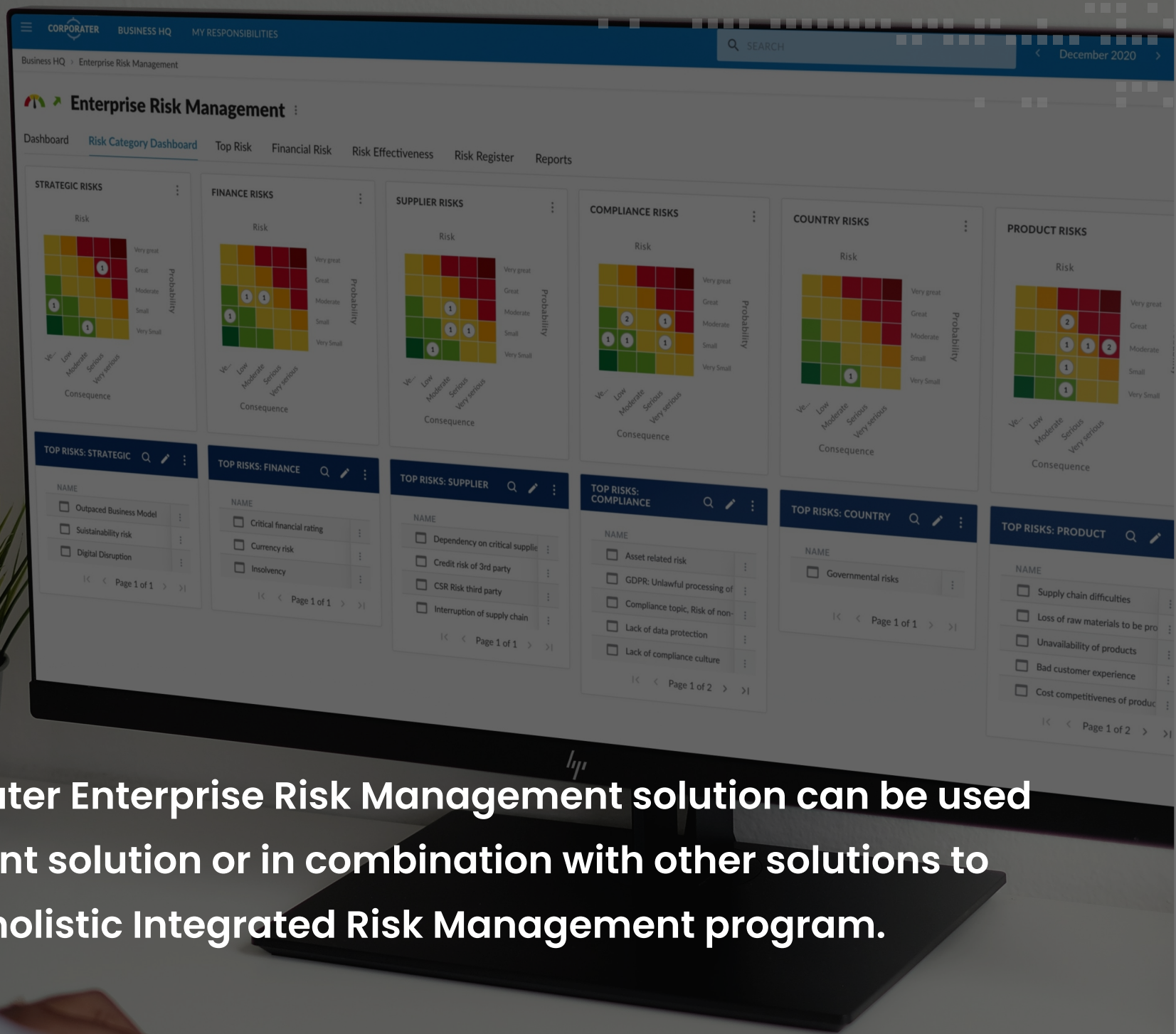

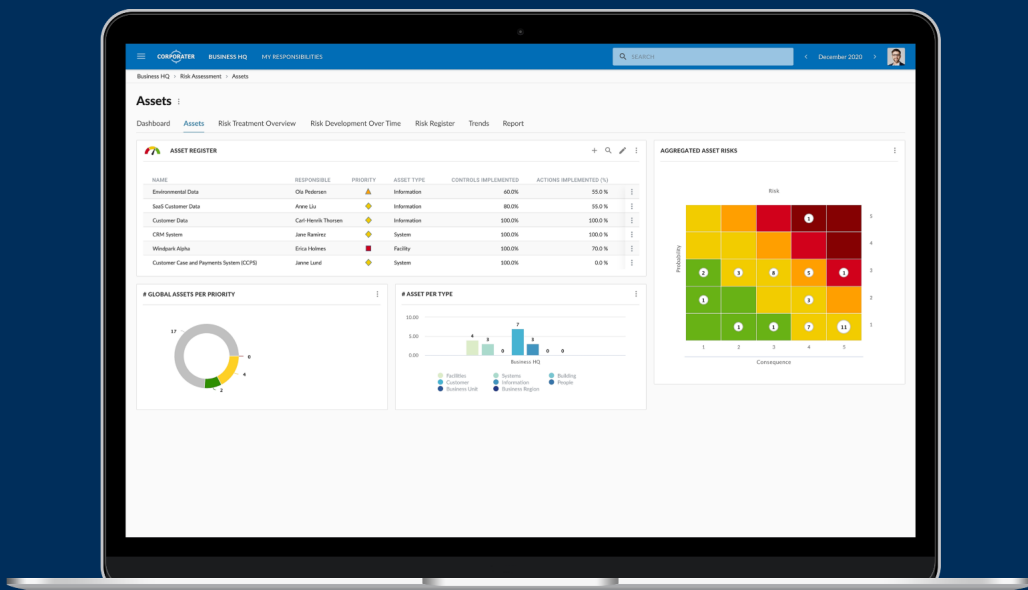
